Based upon current available supplier information and knowledge of the manufacturing processes, the products mentioned below do not contain any intentional addition of:

- Hexavalent Chromium (Cr)
- Polybrominated Biphenyls (PBB)
- Polybrominated Diphenyl Ethers (PBDE)
